There have also been significant changes in some of the regulatory and administrative frameworks for estate agents all of which practising estate agents should acquaint themselves with to ensure compliance and to maintain the economic and professional well-being of their enterprises. This will be covered in the EAAB Compliance, and Property Transformation Sector Council presentations.
